INSURANCE CONSULTANT

Scope of Services:

The Black Horse Pike Regional Board of Education desires to appoint an insurance broker of record responsible for the negotiation and placement of various insurance products required by the Board of Education including, but not limited to, general liability insurance including crime, boiler and machinery, automobile and employee benefits liability insurance, errors and omissions insurance, school board legal liability insurance, environmental impairment insurance including storage tank coverage, student accident insurance, and others. Applicant should demonstrate an extensive knowledge of all insurance products required by governmental entities and available product lines. Any experience or knowledge of matters directly affecting the Black Horse Pike Regional Board of Education should be addressed.

Mandatory Minimum Qualifications:

- 1. Must be licensed as a New Jersey insurance broker for a minimum of ten (10) years.
- 2. Must have a minimum of five (5) years' experience representing New Jersey school districts as an insurance broker.
- 3. Must handle all insurance products required by Black Horse Pike Regional School District.
- 4. Must have access to various competitive insurance lines.
- 5. Must have available risk management consultant services as requested by the Board of Education.
- 6. Must be able to provide consulting services relative to self-insurance programs and other alternative insurance options.
- 7. Must list past and present governmental entities served as Insurance Broker.

- 2. Describe ability to provide services in a timely fashion including a description of your staffing and a description of your familiarity with the services required by the Board of Education of the Black Horse Pike Regional School District.

The School District intends to award a professional services contract for the defined scope of work under the Fair and Open Process in accordance with N.J.S.A. 19:44A-20.4 et seq.

It is the contractor's responsibility to identify the specific committees to which contributions may have been made and need to be disclosed. The enclosed form, a content-consistent facsimile, or an electronic data file containing the required details (along with a signed cover sheet) may be used as the contractor's submission and is disclosable to the public under the Open Public Records Act.

The contractor must also complete the attached Stockholder Disclosure Certification. This will assist the agency in meeting its obligations under the law. **NOTE: This section does not apply to Board of Education contracts.**

A person who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) to report, for example, income paid to you, real estate transactions, mortgage interest you paid, acquisition or abandonment of secured property, cancellation of debt, or contributions you made to an IRA.

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN to the person requesting it (the requester) and, when applicable, to:

- 1. Certify that the TIN you are giving is correct (or you are waiting for a number to be issued),
 - 2. Certify that you are not subject to backup withholding, or
- 3. Claim exemption from backup withholding if you are a U.S. exempt payee. If applicable, you are also certifying that as a U.S. person, your allocable share of any partnership income from a U.S. trade or business is not subject to the withholding tax on foreign partners' share of effectively connected income.

Note. If a requester gives you a form other than Form W-9 to request your TIN, you must use the requester's form if it is substantially similar to this Form W-9.

Definition of a U.S. person. For federal tax purposes, you are considered a U.S. person if you are:

- An individual who is a U.S. citizen or U.S. resident alien.
- A partnership, corporation, company, or association created or organized in the United States or under the laws of the United States,
- . An estate (other than a foreign estate), or

• A domestic trust (as defined in Regulations section 301.7701-7).

Special rules for partnerships. Partnerships that conduct a trade or business in the United States are generally required to pay a withholding tax on any foreign partners' share of income from such business. Further, in certain cases where a Form W-9 has not been received, a partnership is required to presume that a partner is a foreign person, and pay the withholding tax. Therefore, if you are a U.S. person that is a partner in a partnership conducting a trade or business in the United States, provide Form W-9 to the partnership to establish your U.S. status and avoid withholding on your share of partnership income.
